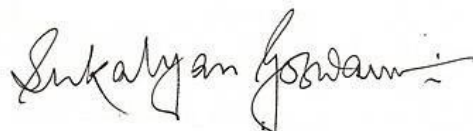
The power and the functions of this Committee will be as follows-

- While dealing the complaint, the committee will observe law of natural justice and hear the complainant and concerned people
- While passing an order on any Grievance, the relevant provisions of Act/ Regulations of the University should be kept in mind and no such order should be passed in contradiction of the same.
- To discharge the duties assigned by the Chairman as and when required.
